Please note that the following requests do *not* require production of any documents in the administrative file for NTMP 1-06NTMP-011 SON, at the Cal-Fire office in Santa Rosa; or production of any documents relating to NTMP 1-06NTMP-011 SON on the Cal-Fire website ([ftp://thp.fire.ca.gov/THPLibrary/North\\_Coast\\_Region/NTMPs2006/1-06NTMP-011SON/](ftp://thp.fire.ca.gov/THPLibrary/North_Coast_Region/NTMPs2006/1-06NTMP-011SON/)).

I request Cal-Fire to provide copies of all records up to the present related to the Bohemian Grove NTMP 1-06NTMP-011 SON. This includes but is not limited to the following:

1. Communications between Cal-Fire personnel and members, representatives, or agents of the Bohemian Club, including its attorneys.
2. The Bohemian Club's proposed donation of a conservation easement to the Rocky Mountain Elk Foundation or any other group, person, or organization.
3. Any unfiled amended NTMP, new NTMP, or amendments to the Bohemian Club's currently filed NTMP.

Prior to making copies, please inform this office of the cost for copies of these records.

Government Code section 6253, subdivision (a) states that upon a request for a copy of records an agency must make the records promptly available. Please inform us when you will make the requested records available.
